Residents pay an ingoing contribution and ongoing service fees which are annually determined by the Heatherlie Council. The service fee covers building maintenance and insurance, power costs, council water and wastewater rates and the upkeep of the landscaped gardens. A professional coordinator is available to assist residents with any daily questions and advice.
